4. FIRST AID MEASURES

INHALATION: Remove from exposure immediately. Use a bag valve mask or similar device to perform artificial respiration (rescue breathing) if needed. Get medical attention.

5. FIRE FIGHTING MEASURES

Handle and store in accordance with all current regulations and standards. Store in a tightly closed dry container and keep in a ventilated, cool and dry place, avoid to contact with acid material and expose to air. Keep away from sources of ignition, refrain from smoking.
